Those cooking or altering a product on stand may require a Temporary Food Stall License and should register with Brisbane City Council by phone 133 263 or website. Exhibitors sampling liquor must supply a current Liquor License and hold a current QLD RSA certificate. External supply arrangements must be fully self-sufficient in regards to transport, storage, refrigeration, waste removal and service.

Food sampling requests must be submitted via the Exhibitor Portal 7 days prior to the bump-in date.

Liquor sampling requests must be submitted via the Exhibitor Portal 35 days prior to the bump-in date.
